What is covered?

Our Motor Private insurance policy provides coverage in case of accidental loss or damage to the insured vehicle, along with legal liability coverage for any harm caused to third parties. Private vehicles are defined as those used for pleasure or in relation to the insured's business only, and include Saloon Cars, Station Wagons, and Double Cabins.

When purchasing motor vehicle insurance, you'll need to choose the level of coverage that suits your needs and budget. There are two different levels of coverage available:

1. **Comprehensive Coverage:** This provides the broadest protection, covering damage to your own vehicle as well as damage to third parties and their property. It often includes coverage for accidents, theft, fire, vandalism, and various other incidents.

2. **Third Party Only:** This is the most basic level of coverage and only covers your legal liability for causing injury to third parties or damaging their property. It doesn't provide any coverage for damage to your own vehicle.

Motor Private Third-Party

This covers Third-Party Liabilities only, in line with the Motor Vehicles Third Party Risks Act Chapter 405 of the Laws of Kenya.

It provides indemnity to the insured and/or passengers for their legal liability arising from accidents involving the insured vehicle or in connection with the loading and/or unloading of such vehicles. The cover is in respect of: -

- 1. Third Party Personal Injury (TPPI): Liability for death of or bodily injury to any person other than employees of the insured who may be injured in the insured vehicle. The cover is usually subject to a policy limit any one person and any one event.
- 2. **Third Party Property Damage (TPPD):** Damage to property, other than property belonging to the insured or held in his custody, trust or control.
- 3. Claimant's costs and expenses of litigation: up to the policy limits.

Limits of Liability

(a) Liability to Third Parties-Death or Bodily Injury (TPPI):

In respect of persons being carried in or upon or entering or getting onto or alighting from the vehicle, and in respect of other persons.

- (I) Death or Bodily Injury to any one person......Kes.3,000,000
- (II) Series of claims arising out of one event......Kes.20,000,000



(b) Liability to Third Parties-Property Damage (TPPD):

In respect of any one claim or a series of claims arising out of one event... Kes.5,000,000
